Call to order (3:30 p.m.)

- 1. Announcements from President Lepre
  - a. Homecoming week lots of activities
  - b. 3<sup>rd</sup> Open House of the year happened on Saturday October 19
  - c. Shared Governance Consortium meeting went well
  - d. Lots of admin meetings about ways to increase reach and diversify revenue
  - e. Q: How many exceptions to the hiring freeze have there been so far? A: Around 2 dozen postings were in the queue were approved last year before the freeze was implemented, Provost has made 3 exceptions in Academic Affairs, unknown in other units, 2 temps focusing on critical need. Many of the staff positions approved last year were held to bolster savings between July-October. Roughly 24 faculty positions already approved were budgeted into FY26 due to when faculty contracts would start.
  - f. Q: Is it true that we're closing our Zoom account? A: Decision has not been made. Investigating the best use of cost-saving resources as both Teams and Zoom cost a lot of money.
    - Follow-up comment: Consider business practices AND pedagogy.
      Internal meetings AND student teaching.
    - ii. Next step from Aurora's office is to solicit feedback from campus constituents, including faculty.
    - iii. Follow up Q: Should this be brought before the Faculty Senate? A:Yes, once there is some data to present.
- 2. Approval of Minutes from October 8, 2024 meeting
- 3. Announcements from Provost Couch
  - a. Met with Graduate Student Council President interested in helping with recruiting. If Grad Program Directors have ways or ideas for them to get involved, contact Graduate Student Council.
  - b. Middle-States Site Team Lead Nov 6 will be on campus, going through preliminary report and providing feedback.

- c. Kudos to Jessica Clark and Kara Raab for leading Middle States process, as well as the many other things they are handling.

- e. New Dean of the Libraries has accepted, name to come as soon as this individual tells their Provost
- f. Very close to announcing CHHS Dean
- g. Perdue Dean candidates on campus this week
- h. Q: Is Middle States Review like a department Academic Program Review or campus wide? A: Campus wide
- i. Q: Al Task Force, will decisions come back to Faculty Senate? A: Policy decisions will go to APC, there may be other types of recommendations that will go to their appropriate committees.
- j. Q: What is the timeline for hiring department faculty? Is it same as faculty and staff? A: Multiple levels of review needed with data justifications, takes a long time. There were both faculty and staff positions that didn't make it through all levels. Timeline would be the same, but faculty decisions require different types of data.
  - Follow up comments: Seems like we're going through the "adjunctification" of departments. We've seen a lot of growth in the administration but that is not reflected in the faculty.

## 4. Announcements from the Senate President

- a. Welcome Kwon Jeon from Public Health to Senate
- Recommendation based on a motion from October 24th, 2023 to include "Belonging" in the Faculty Senate DEI statement in the faculty handbook has been implemented.
- c. Ad Hoc Committee on Faculty Pay and Benefits has three volunteers so far (Christina Camillo (Medical Laboratory Science), Elizabeth Emmert (Biology), Maida Finch). Hoping for one or two more – contact Senate President to volunteer
- d. Faculty Senate will meet with Middle States reviewer
- e. Cede to Peter from SGA (Deputy Director of Academic Affairs)
  - SGA would like to work with Faculty Senate more. If we have shared items of interest, events, advertising, tabling, questions – SGA would love to collaborate.
  - ii. SGA is planning an Al Seminar in late November with guest speaker

## 5. Committee Reports

a. APC Response to Religious Observance Accommodations (plus motion)

- i. Sent this motion to several groups including Staff Senate and Faculty Welfare Committee
- ii. FWC requested language make it very clear that cases of suspected discrimination will be sent to Office of Institutional Equity
- iii. Which group/office should be listed related to responsible groups or departments: Faculty Senate as an "owner" of the policy. Idea is that when changes are made to this policy it would come back to Faculty Senate
- iv. Comment that it will bog OIE down if all grievances go through them and take too long to resolve anything
- v. Will need to keep clear, thorough documentation
- vi. In the future, Disability Resource Center will likely change their name to handle accommodations more broadly
- vii. Be careful to not penalize students for making accommodation requests
- viii. When you say "centralized office that handles accommodations" is that DRC? Some other office? Are they appropriately staffed to handle that?
- ix. Centralization for procedures can be helpful, but there is a great diversity of pedagogical approaches, classroom needs, and impacts of missing learning time (labs, experiential learning, clinicals)
- x. Idea to disconnect faculty from student requests
- xi. Just because a student makes a request, does not mean it will be granted. Will enter an interactive process with the student to explore options.
- xii. We have a similar "not direct faculty accommodation request" through SU Cares and emergency absence requests, but that system doesn't seem to work because the office is understaffed and overworked.
- xiii. As a reminder, DRC is now under Zebediah Hall
- xiv. If we don't adopt the current motion on the table, we continue to operate under temporary policy adopted in 2023
